

# 2020 Trumbull County Fairboard Camping Rules and Regulations

1. **CAMPING PERMITTED ONLY IN AUTHORIZED AREAS WITH PRIOR REGISTRATION.**
2. **\*\*All occupants staying overnight in all campers or tents will be required to wear a security wristband at all times throughout the week of fair. Wristband is to be on before Tuesday, July 7, 2020 at 11pm. \*\***To acquire a security wristband at the Fair Office, you must show one of the following: your advisor pass or your junior fair wristband or purchase a membership @ \$25, a weekly fair pass @ \$23 or an exhibitor pass with competition entry @ \$18; and be listed on the Camping Registration form as allowed to stay. These passes can be purchased at the Fair Office Monday through Friday during the months of April & May 9 to 4 and June from 9 am until 5 pm and you must be 18 years or older to get a camping permit. You must have your pass with you to pick up your camping permit. **One adult must stay in camper. The camping area will be policed so we urge you to obey this rule in case you are asked to show one of the above requirements. Without a wristband, you will be taken off the fairgrounds.**
3. **CAMPING PERMIT PROVIDES FOR:**
  - A. One campsite rented per family. If **over all length (hitch to bumper)** of camper is over 30' you must buy two sites – head to tail.
  - B. **\*\*1.)** Camping fee will be \$150.00 for each 30' site. (One camper per site) For those campers over 30' two sites, head to tail, can be purchased for \$200.00 (One, 30' plus, camper per double site).  
**2.) Anyone staying over-night on the Fairgrounds, in an area other than the Campgrounds and Vendor area, must register at the office as primitive camping and pay a \$75.00 weekly fee. This includes persons staying in motorized vehicles, horse/stock trailers, or other mobile units. Anyone found in violation will be removed from the Fairgrounds.**
  - C. Camping permit **must be** displayed on the door of the camping unit, or on the window to the right of the door, and **must be** visible at all times.
  - D. **\*\*Deadline for renewal is Friday, May 1, 2020 before 5 pm or POSTMARKED May 1, 2020. \*\***For those that have paid for their sites by the May 1<sup>st</sup> deadline and would like to relocate you can come in the week of May 11<sup>th</sup> - 15<sup>th</sup> and see what is available and change sites before we reopen to the public.\*\*
  - E. **\*\***Campsite rentals will re-open for new campers or changes on **Saturday, May 16, 2020** in the Fairboard Office from 9:00 am until 4 pm and remain on sale until all sites are sold or first day of fair. You must be present to rent a campsite on May 16, 2020. No one will be permitted to rent a campsite for another person.
  - F. All camping units will enter by Gate “C “and will be staged in either the EXPRESS lane or the regular lane for early entrance at **5:00** am on Saturday, July 4<sup>th</sup> If you have picked up your packet prior to set-up and have it with you on July 4<sup>th</sup> you will be staged in the express lane to enter at **5:00** am. All others will be parked in a separate lane and will have to report to the office window (opens @ 8:00 am).to pick up your packet before entering grounds.
  - G. No refunds of camping permit after the opening of the fair.
4. **CAMPSITES:** Camper set-up date will start Saturday, July 4, 2020 @ 5:00 am. All camper units shall be in place by 10:00 am Tuesday, July 7, 2020. **\*\*NOTE: Please leave awnings up and slide-outs in until the start of fair. It will leave room for all campers to get into their sites easier.**
  - A. Only one unit per site or per double sites rented (trailer, tent, pop-up, 5<sup>th</sup> wheel). Units **MUST be pulled-in or backed-in, tongue out or engine out within lines on site. Once parked 5<sup>th</sup>**

**wheel campers or gooseneck trailers need to attach a bright colored caution tape to the farthest part of camper or gooseneck sticking out towards the roadway.**

- B. Only one vehicle per campsite or double sites rented (car or pickup). **Vehicle MUST fit within lines and are not permitted to park across from the camp ground or near barns or roadways at any time.**
- C. **At no time will any vehicle or camping unit move in the camping area between the hours of 10 am and 11 pm** after the start of the fair. If an emergency arises that you must move during the stated hours, written permission must be obtained from the fair office or **Director in charge.**
- D. All electrical hook-ups shall be in compliance with the National Electrical Code (NEC). A 110 volt, 30 AMP R.V. type receptacles protected by a 20 AMP GFCI circuit breaker is provided. All extension cords shall be "UL" approved with a minimum of 12 gauge wire. "Think Green, Conserve Energy"
- E. **\*\*All campers must have a backflow preventative valve installed where the city water hook up is located.\*\***
- F. **You must provide your own picnic tables. No borrowing of fairgrounds tables.**
- G. Trailer to trailer hook-ups **will not be permitted** and No outside appliance over 4 cu. ft.
- H. There will be no generators run in the camping area when electric hook-ups are provided.
- I. **Curfew hours must be observed from midnight to 6 a.m. and will be enforced.**
- J. Dumpsite for trailer waste will be provided. Ask at Fair Office for location.
- K. No campfires or open flames will be allowed on the fairgrounds in accordance with 1301.7-7-04 open flame, Ohio Fire Code.
- L. No waste will be dumped directly onto the ground – liquid or solid.
- M. **No cars, vans, or trucks will be parked on the campground roads.** This is in accordance with 1301.7-7-03 Sec. K, F/311.0, and Fire Lane, Ohio Fire Code.
- N. **\*\*NO SWIMMING POOLS OF ANY KIND ARE ALLOWED ON FAIRGROUNDS!!!** Per rule #8 in General Rules under Miscellaneous in fair book.

5. **No alcohol beverages or drugs will be permitted in the campgrounds.**

6. **All animals needing rabies vaccination that are coming to or staying at the Trumbull County Fairgrounds MUST have been vaccinated at least 21 days prior to coming onto fairgrounds by a licensed veterinarian and a copy of the paper work must be filed with camping registration in Fairboard Office.**

7. **All animals staying in campground MUST be confined to campground area. They are NOT PERMITTED in the Barns, Midway, Grandstand or "Oak Grove" areas. All pets shall be on a leash.**

8. **\*\*Release time for all campers on the last day of the fair will be 10 p.m. !!! NO EXCEPTIONS Any camper left after Wednesday, July 15<sup>th</sup> will be moved and charged a \$50 per week storage fee. (Gate C will remain open 24 hours from close of fair until Thursday, July 16<sup>th</sup> at 5:00 pm close of office)**

9. **ANY VIOLATION OF THESE REGULATIONS** and you will be removed from the fairgrounds and lose your campsite for the next year.

10. For Emergency **Dial 911.** The Trumbull County Sheriff's Office is located under the Grandstand week of fair.
